**MODIFIED CHECK LIST BEFORE SUBMISSION OF PENSION PAPERS  
OF EMPLOYEES OF NON-GOVERNMENT AIDED COLLEGES TO  
THE PENSION SANCTIONING AUTHORITY**

The Principals of Non-Govt. aided colleges being the head of the office in respect of the employees working under their control process the pension papers both hard file and online to the Pension Sanctioning Authority i.e. (Director, Higher Education, Odisha),

While processing the pension papers of the retired / expired employees their Service Book should be updated and pension papers should be filled up properly in order to avoid objections from the Directorate as well as from the Controller of Accounts.

Following things should be taken care of while preparing / processing the pension papers:

- 1) Provisional Pension should be sanctioned in favour of the retired employees on or before the date of retirement.
- 2) Multiple sanction of provisional pension may be avoided.
- 3) In case of death, provisional Family Pension should be sanctioned on the date of receipt of application along with related documents like death and legal heir certificates etc.
- 4) Priority should be given for processing of pension papers for sanction of pensionary benefits in favour of legal heirs in case of death of an employee.
- 5) Initiation for sanction of pensionary benefits should be started at least before six months of superannuation.

- 6) Pay particulars from the date of joining till receipt of GIA should be recorded in the Service Book.
- 7) The details of sanction of GIA should be recorded in the Service Book with rate of GIA i.e. 1/3<sup>rd</sup>, 2/3<sup>rd</sup>& Full and the copy of GIA Order should be appended in the S.B.
- 8) The original pay fixation statement approved / checked by the competent authority should be appended in the service book concerning to fixation of pay under ORSP Rules and promotional fixations.
- 9) The details of pay particulars and fixation of pay should be recorded in the Service Book.
- 10) In case of teaching staff the incremental pay allowed Rs.17070/- w.e.f. 01.01.2008, Rs.17730/- w.e.f. 01.01.2009 and onwards should be re-examined and correct incremental pay be allowed with recovery of excess drawn.
- 11) Service verification certificate from the date of joining till retirement/ death should be checked. In case of any tampering re-verification to be made.
- 12) Placement/Promotion details should be recorded in the Service Book.
- 13) In case of Ministerial staffs details of completion of Accounts training should be recorded in the Service Book.
- 14) MACP allowed without completion of Accounts Training should be re-examined pursuant to Clause-XVIII of Rule-15 of ORSP Rules, 2017 (For Non-Govt. Aided colleges)
- 15) Date of receipt of Full GIA should be mentioned in the MACP statement.

- 16) NDC pre-condition certificate from all the quarters, the employee served, should be recorded in the Service Book.
- 17) Leave sanctioned should be recorded in the Service Book.
- 18) Leave account should be updated till date of superannuation / death.
- 19) Date of Superannuation and details of sanction of provisional pension should be recorded in the service Book.
- 20) All entries should be signed by the Principal in the Service Book incorporating dates.
- 21) LPC should be submitted in the format prescribed under OTC with obverse and reverse pages.
- 22) Last Emoluments recorded in the Service Book, Pension Papers & LPC should be identical.
- 23) All pension forms prescribed in Finance Deptt. Office Memorandum No. 32321/F, Dt. 22.11.2021 should be filled-up properly/correctly.
- 24) Pension papers in the old formats should not be submitted
- 25) Proper designation of the pensioner should be mentioned in the pension paper.
- 26) Using of wrong designation will be viewed adversely( Example-Associate Prof. Asst. Prof.etc.)
- 27) Admissible pension forms and related documents like Legal heir certificate, in come certificate, non-marriage certificate should be submitted in case of family pension.
- 28) In the pension paper the name of family pensioner should be mentioned.
- 29) The active phone number of the pensioner should be mentioned in the pension form

30) The period of qualifying service should be calculated from the date of admissibility of the post / date of validation in case of employees appointed by college management. In case of employees appointed being sponsored by the SSB the period of qualifying service should be calculated from the date of joining.

31) Period of EOL on private ground period of suspension treated as such and other periods as specified under OAIERB Rules, 1981 should be treated as non-qualifying service.

32) In most of the cases the Principals are submitting pension papers putting signature at the place of pension sanctioning authority unauthorizedly.

33) In case of employees remaining in charge of Principal, the Service Book for that period should be maintained by the President G.B.

34) Audit clearance report should be submitted for remaining in-charge of Principal.

35) In absence of Audit Clearance report, 4(c) bond should be executed from Executive Magistrate.

36) In case of employees subscribing EPF clearance of EPF organization should be submitted for processing of Pension Paper.

37) The name of Treasury in which pension is payable should not differ in offline & online pension form.

38) The details of sanction of provisional pension should be recorded in the Service Book.

39) While submitting pension paper to the Pension Sanctioning Authority, the copy of letter may be extended to the pensioner concerned.

40) The Principals are requested to keep a permanent Head of Office (HOO) ID of the college in the IFMS portal for submission of Online Pension Paper. Subsequent Principals can change the password. Change of ID with the change of Principals is creating problems while reverting the Online papers in case of objection by the office of the Pension Sanctioning Authority / Controller of Accounts, Odisha.




